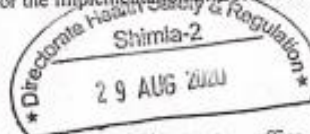

The empanelment shall be subject to following terms and conditions:-

- The empanelment shall be extendable for one year subject to renewal after one year on satisfactory Performance and private hospital will apply for renewal one month before the date of expiry along with inspection fee as decided by the Government in the shape of Demand Draft in favour of CEO-cum-DHSR, Society for the implementation of ESI scheme in H.P.
- All terms and conditions laid down in request for proposal and MOU signed with the Society shall be binding on all empanelled Hospitals.
- During the empanelment period, the inspection team constituted for the purpose will visit the empanelled institution and if the institution is not found to have services as per the parameters fixed by the Government of H.P. the empanelment shall be withdrawn.
- The management of the above Hospital shall deposit the required inspection fee.
- There is no dispute, litigation and controversy pending in any Court of Law or in the offices against the said hospital, which could jeopardize or adversely affect the interest of the patients care at large. In case the discrepancy is found at any point of time it would lead to cancellation of empanelment without further notice/reason.
